Dear Ohio Attorney General Dave Yost:

This letter is for notifying you, Ohio Attorney General Dave Yost, of the matter herein. I am now giving you, Ohio Attorney General Dave Yost, notice that the letter that I mailed to you on August 10, 2019 via certified mail using the certified mail number 70150640000642170591 has no intent of complaining. The letter thereof was written and mailed to you with the intent of notifying you of possible false advertising, contract fraud, and false conveyance of language by Weltman, Weinberg & Reis Co., the debt collector with the address 3705 Marlane Drive, Grove City, OH 43123. The address of Weltman, Weinberg & Reis Co. is within your territory and therefore is a franchise of your State. The letter thereof was also written and mailed to you, Ohio Attorney General Dave Yost, with the intent of commanding you to investigate Weltman, Weinberg & Reis Co. for possible false advertising, contract fraud, and false conveyance of language.

I am now giving you, Ohio Attorney General Dave Yost, further notice that I, the Man who is living and peaceable and has God-given rights, have already claimed that I am the rightful and lawful owner of my Given Name, Pao Lee Chang, and DNA; I have also claimed that I am the rightful and lawful owner of my Natural Body and all biological substances thereof; furthermore, I have acknowledged, accepted, and claimed my Given Name, DNA, and Natural Body and all biological substances thereof as my properties; in addition, I have conveyed my Given Name to, and declared its permanent domicile on, the land and soil of Minnesota. CHANG, and all other variations thereof however spelled, styled, punctuated, or ordered, that are used to represent me and my estate, and associate with my Given Name in any way whatsoever, ought to be used peaceably and honorably. My Given Name and all trade names and derivative names thereof must not be used for harming me, nor for waging war against me, nor for committing personage, barratry, identity theft, and fraud, nor for stealing my currency, life force, and energy in any way whatsoever; furthermore, they must not be used for deceiving me to surrender my God-given rights and kingdom of God. I have also conveyed all trade names and derivative names thereof to, and declared their permanent domicile on, the land and soil of Minnesota. For more information about my claims herein, please contact Secretary of State Michael R. Pompeo and your master Pope Francis.

I am now giving you, Ohio Attorney General Dave Yost, further notice that God gave man dominion over all the earth and breathed into his nostrils the breath of life, giving man the Spirit of God and the divine power to rule over all the earth; therefore, I, the Man who is living and peaceable and has God-given rights, am acknowledging, accepting, and claiming my dominion, and giving notice to all governments, which are corporations or legal fictions, that they have no dominion over man. All governments and their agents are obligated to honorably serve man, individually and collectively.

Then God said, "Let Us make man in Our image, according to Our likeness; let them have dominion over the fish of the sea, over the birds of the air, and over the cattle, over all the earth and over every creeping thing that creeps on the earth." (Genesis 1:26)

I am now giving you, Ohio Attorney General Dave Yost, further notice that God is the Supreme Ruler of all governments. God created man and gave man dominion over all the earth; man created governments to honorably serve man; therefore, all governments and their agents are under the jurisdiction of God and man. The creation is never greater than the creator. In other words, God is first-in-command; man is second-in-command; and government is third-in-command. Any and all laws, acts, statutes, codes, rules, and regulations of the United States government, and any and all laws, acts, statutes, codes, rules, and regulations of any and all governments that are in violation of my God-given rights are immediately null and void. To assert otherwise means that you, Ohio Attorney General Dave Yost, claim that the laws, acts, statutes, codes, rules, and regulations of the United States and its franchises are above God's Law.

As Ohio Attorney General, it is your duty to order any and all franchises of your State to operate within their jurisdiction and under the codes, regulations, statutes, and laws of your State. Otherwise you, Ohio Attorney General Dave Yost, must answer to God and His servants; furthermore, you can be liable for the acts of your franchises and agents.

For the failure to respond to this letter within 30 days of receiving this letter is acquiescence and agreement to this letter by you, Ohio Attorney General Dave Yost. You, Ohio Attorney General Dave Yost, are now notified of my claims herein and therefore can be liable for any and all harms and damages that are done to me by you, your agents, and your franchise Weltman, Weinberg & Reis Co. If I do not receive a letter from you, Ohio Attorney General Dave Yost, within 30 days of receiving this letter, I will notify your superior William Pelham Barr of the matter herein. Your response letter must have information about your investigation of Weltman, Weinberg & Reis Co. for false advertising, contract fraud, and false conveyance of language. Notice to agent is notice to principal and notice to principal is notice to agent.

Joint Resolution

Authorizing and requesting the President to proclaim 1983 as the "Year of the Bible".

Oct. 4, 1982
[S.J. Res. 165]

Whereas the Bible, the Word of God, has made a unique contribution in shaping the United States as a distinctive and blessed nation and people;

Whereas deeply held religious convictions springing from the Holy Scriptures led to the early settlement of our Nation;

Whereas Biblical teachings inspired concepts of civil government that are contained in our Declaration of Independence and the Constitution of the United States;

Whereas many of our great national leaders—among them Presidents Washington, Jackson, Lincoln, and Wilson—paid tribute to the surpassing influence of the Bible in our country's development, as in the words of President Jackson that the Bible is "the rock on which our Republic rests";

Whereas the history of our Nation clearly illustrates the value of voluntarily applying the teachings of the Scriptures in the lives of individuals, families, and societies;

Whereas this Nation now faces great challenges that will test this Nation as it has never been tested before; and

Whereas that renewing our knowledge of and faith in God through Holy Scripture can strengthen us as a nation and a people: Now, therefore, be it

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the President is authorized and requested to designate 1983 as a national "Year of the Bible" in recognition of both the formative influence the Bible has been for our Nation, and our national need to study and apply the teachings of the Holy Scriptures.
